Cancellation Policy: Refund of tuition or deposit will be granted upon written request received in the OAR office at least ten (10) days prior to the first day of the REALTOR® Institute for which the payment was made. When any written request is received during the period beginning nine (9) days prior to the REALTOR® Institute up to the start of class, no refund of tuition paid will be granted but will be transferable to the next Institute.
